AmeriCorps is doing capacity building. Clarice guides the AmeriCorps volunteers. Building relationships with community and parents. Other AmeriCorp volunteers contacted all freshman to welcome them to Englewood. EEF (Englewood Educator Foundation) to have a wider reach with our community. This falls under the 21st Century Grant - TEC, Cherrelyn and CFHSC.

# 6:50-7:40 School and District Performance frameworks

- Reviewed school and district performance:
  - Joanna Polzin (Director of Assessment & Analytics) shared her Google Slides.
  - SPF School Performance Framework
  - DPF District Performance Framework
  - State can come in to support schools with their rating.
  - Ratings:
    - Key Performance Indicators:
      - Academic Achievement weighted at 40%
      - Academic Growth weighted at 60%
      - Postsecondary and Workforce Readiness:
        - Frozen 2014-2015 (no growth data)
        - We dropped this year in several areas. The district went from accredited to priority improvement.
        - CHWS, Cherrelyn, Bishop, EMS and EHS dropped.
        - This needs to look better to show our kids are achieving at a higher rate.
        - The growth piece can really influence and impact the results.
        - Kids that refuse to take the test you lose a level.
        - DPF filing a request to reconsider. You can only submit one every other year for SPF.
        - EMS dropped to a turnaround. A state liaison will help identify areas of improvement. Lowest performing category. They have two years to get out of it.
        - All the ratings are on a bell curve.
        - The state board will be exploring this issue.
        - We will look into an accreditation process.

- When students join our district at different times of the year, it does influence test scores.
- Equity for our ELL students is needed.
- What is the data telling you? Teachers are great at analyzing data but not with what to do next. Each building has a Professional Learning Coach to help. For Math, it is curriculum. We have a Math Cohort this year and unpacked the standards. Taking universal instruction and making it meaningful for all kids is our goal - it is very hard.
- CFHSC rating? Rated on a different set of indicators they are improvement. Student engagement was not reflective of that school. Dr. Skaggs and her team have been so intentional. They have worked so hard. They are a fantastic example of a staff coming together and leaders creating that demand.
- Improvement Strategies (UIP Unified Improvement Plan)
  - Looking a District perspectives and Sites.
  - Strategic Plan
  - Focus first, best instruction
  - Meeting the needs of students
  - Developing our teachers
  - Looking at EMS on turnaround meeting with CDE for further guidance and support. We will talk with CDE about all of our schools.
